Please note:

New players 1st carnival is covered by insurance at Board sanctioned events.

Casual players, after 2 carnivals played, will be fully affiliated. No casual player, who has attended one carnival, can participate at Board run fixtures unless final payment of \$80 is received by the Treasurer 14 days prior to R&R Trophy & Inter-Assn Championships as per by-laws.

Social Member – Casual Player this allows a paid up Social Member to play one carnival, per season, at their Clubs local carnival without having to pay the Casual Player levy; if they play again in the season they then must pay the full fee to upgrade to a playing member. The carnival levy of \$10.00 still applies. The intent of this is for genuine social members of your Club – not for overseas players.

Junior Member to be under 16 years of age as at 1st January - as per IPC Rules

Sub Junior is someone new to the game (under 16 years of age), not yet capable of playing in a team at a carnival competition; or for very young players (i.e still on lead ropes or requiring help on the field). Sub Juniors may upgrade through the season by paying the additional membership fee. **Sub Juniors are not required to pay a Carnival Levy to the Board.**

Pony Club Affiliation: To encourage growth within the sport any member of a registered NZ Pony Club, under the age of 21 years, can pay a reduced affiliation fee (set annually by the Board) which shall allow that player to play at a maximum total of 5 carnivals or competitions within a polocrosse season without having to affiliate fully. After completion of 5 carnivals they can upgrade to a full affiliation by paying the balance of the affiliation fee due.

Proof of Pony Club registration is required.

Carnival Levies for National Fixtures:

<u>Junior & Intermediate Championships</u> Carnival levy to Board = \$60.00 per team of 6

Roke & Rockwood Championships Carnival levy to Board = \$90.00 per team of 6

<u>Inter Association Championships</u> Carnival levy to Board = \$90.00 per team of 6

LATE ENTRIES: Please note late entries to National Fixtures are at double the normal entry fee!

- Acceptance of Risk: Polocrosse can be a dangerous activity; I understand that accidents and injuries can happen. I have read the disclaimer and acknowledge the dangers, and agree to take part in these activities at my own discretion.
- No Liability: I will not hold NZPX, or any Club or Association of NZPX or their respective officers responsible for
 any claims, losses, expenses or costs (including legal costs) which may arise from or in connection with my
 membership and / or participation in any NZPX event except in the case of gross negligence or a willful act of
 omission on the part of the Club, Association or NZPX.
- Indemnity: I indemnify the Club, Association or NZPX from all claims, losses and expenses (including legal costs) suffered or incurred at any time as a result of, or resulting directly or indirectly from, my failure to observe the constitution, regulations, guidelines, policies and reasonable directions of the Club, Association or NZPX respectively.
